- 1. Instructions to the Bidders to submit the bids online through the Public Procurement Portal for e-Procurement at <a href="https://etender.up.nic.in">https://etender.up.nic.in</a>
- **2.** Possession of valid Digital Signature Certificate (DSC) and enrollment/registration of the Contractors/bidders on the e-Procurement/e-tender portal are prerequisite for e-tendering.
- **3.** Bidder should register for the enrollment in the e-Procurement site using the "Online Bidder Enrollment" option available on the home page. Portal enrollment is generally free of charge. During enrollment/registration, the bidders should provide only valid and true information including valid email id. All the correspondence shall be made directly with the contractors/bidders through email id as registered.
- **4.** Bidder need to login to the site through their user ID/ password chosen during enrollment/registration.
- 5. Then the Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by SIFY/ TCS/ nCode/ eMudra or any other Certifying Authority recognized by Controller of Certifying Authorities (CCA) India on eToken/ SmartCard, should be registered.
- **6.** The registered DSC only should be used by the bidder in the transactions and should ensure safety of the same.
- **7.** Bidder may go through the tenders published on the site and download the Tender documents/schedules for the tenders.
- **8.** After downloading / getting the tender document/schedules, the Bidder should go through them carefully and then submit the documents as required, otherwise bid will be rejected.

### 1. Introduction

Jhansi is one of the beautiful cities in Uttar Pradesh. The city is synonymous with the name of Rani Jhansi. The history of Jhansi attracts tourists from all over the world. The city has potential to develop as an independent growth centre and attract migrants from nearby areas.

Jhansi has a tourist footfall of about 80, 35,046 in the year 2019 with domestic tourist visits of 78, 91,785 and foreigner visits of 1, 43,261. The Jhansi tourist zone ranks third in the state of Uttar Pradesh after Agra and Prayagraj. The tourist visitors in the Jhansi from 2015-2019 are shown in the figure below. It can be noted that increase in trend of both domestic and international travelers started from the year 2017 till 2019.

Jhansi is well connected to all other major towns in Uttar Pradesh by road and railway networks. The National Highways Development Project has supported development of Jhansi. Srinagar to Kanyakumari North-South corridor passes through Jhansi as does the East-West corridor; consequently, there has been a sudden rush of infrastructure and real estate development in the city.

## 2. About Project

Jhansi Smart City focuses on strengthening the economic status along with improvement of basic social infrastructure. This included aim to accelerate economic growth in the city resulting in socio-economic upliftment. Jhansi houses more than 0.5 million people which indicates that the city has a lot of potential for economic activities. In order to achieve good economic and employment opportunities there have to be good trade and business facilities. Just like any other city Jhansi also has different scales of economic activities that is small, medium and large scale.

Thus, it deserves to have a good business facility which can help the trade and commerce to strengthen and eventually which can strengthen Economic Status of the city.

Jhansi Smart City Limited has developed one New Incubation Centre at Nagar Nigam Campus near Elite Circle which has provision of 4 Nos. Shops/ Showrooms at Ground Floor to provide retailer and wholesaler vendors a better place of business.


