1. Background and Overview

- 1.1. This document has been created to invite bidders to show their expression of interest for below works:
 - 1.1.1. Operating the Multilevel Car Parking (MLCP) located near Elite Crossing, Jhansi
 - 1.1.2. Developing and operating a rooftop restaurant in the same building with related commercial activities
 - 1.1.3. Operation of 24 shops in the same building
- 1.2. A building consisting of multi-level parking and 24 shops has been developed by Jhansi Smart City Ltd (also referred as JSCL). This building consists of below amenities/features in the building:
 - 1.2.1. Parking space consists of basement + 4 floors with a total parking capacity of approximately 230 four-wheelers. The facility includes separate entry and exit points, 2 lifts, 2 staircases, and availability of electricity and diesel generator backup.
 - 1.2.2. Above building has also a rooftop (area approx. 17,000 sq. ft.). Currently lifts are not till rooftop. Successful bidder needs to extend the lifts till rooftop on his own expenses. Rooftop offers a premium view including Jhansi Fort.
 - 1.2.3. Above building has also 24 shops of different sizes on ground floor.
 Details layout with area details etc. is attached with this document.

- 1.3. EOI is invited from interested parties to propose their solutions to operate and maintain the above infrastructure and earning revenue from various activities and depositing the agreed rent to Jhansi Smart City Itd, Jhansi.

3. Scope of Work

Basic idea of this project is to rent out the above premises on rent to any agency, which will earn the revenue using the infrastructure in the premise and will deposit agreed amount of rent to Jhansi Smart City Ltd. Selection of agency shall be done on the basis of QCBS evaluation. Tentative conditions of the bid/contract are as below:

3.1. Options for successful bidder to generate revenue

- 3.1.1. Parking ticketing including subscription models and per visit charges
- 3.1.2. On-site repair service
- 3.1.3. Vehicle washing service
- 3.1.4. Electric vehicle charging (to be developed by successful bidder)
- 3.1.5. Advertisements in the premise
- 3.1.6. Paid helpdesk for vehicle-related services (e.g. insurance, PUC etc.)

- 3.1.7. Developing and then operating play zone, restaurant or any other amusement activity center on roof of the building
- 3.1.8. Renting out the 24 shops to interested people
- 3.1.9. Successful bidder can generate revenue by any other means also, after the approval from Jhansi Smart City Ltd by CEO or ACEO level.

3.2. Tentative Contract Conditions

- 3.2.1. Project site shall be handed over to successful bidder on AS-IS WHERE-IS condition. Inventory list shall be part of the contract document.
- 3.2.2. No separate handover process shall be executed.
- 3.2.3. Base price to rent out the whole building (as mentioned above) shall be 6 Lakh per month, with 5% annual increment.
- 3.2.4. Contract period shall be 10 years
- 3.2.5. Successful bidder shall be selected on the basis of a QCBS based (70% 30%) tender. Interested bidders have to present their proposed work, previous work experience, including details of how the development and operation of the above site shall be done by them. This presentation shall carry 30% of the weightage and 70% of the weightage shall be given to the rent proposed by the bidder.
- 3.2.6. Successful bidder shall have to deposit security deposit, equal to the amount of 3 months' rent (quoted by the bidder in his bid)
- 3.2.7. All electricity charges shall be borne by the successful bidder. This will be responsibility of successful bidder to obtain the electricity bills and internet bills on its own and make the payment on time.
- 3.2.8. Successful bidder shall have to extend the lift till rooftop on his own expenses.
- 3.2.9. Mobilization period to develop rooftop area shall be 6 months from the signing of the contract. During this period successful bidder shall be allowed not to pay 1/3rd of the agreed rent during the mobilization period. Rest of the amount of agreed rent shall be applicable from the signing of the contract.
